30 August 2011 Waiapu Cathedral Parish of St John the Evangelist, Napier – The effecting of an upgrade of

the pipe organ in the Cathedral of St John the evangelist, Napier by the South Island Organ Company Limited under Contract approved by Sainsbury, Logan & Williams (the Board's Solicitors). The cost of the work is estimated at \$618,000 plus GST to be from:-

- 1. Utilising funding held/pledged of \$283,563.
- 2. Utilising NZ Lotteries Commission Grant of \$180,000.
- 3. Waiapu Board of Diocesan Trustees advancing any bridging finance required.

30 August 2011 All Saints Parish, Weber – The removal and selling of three pews from the Church of All Saints, Weber in order to create more space around the font. No cost is involved.

Turangi Co-Operating Parish – The upgrade of the kitchen and lounge area of the Church of the Cross, Turangi –the design is to upgrade the existing cupboards which will be sanded back, and varnished and new handles affixed with new linoleum, appliances and bench tops being installed. The cost of the work is estimated at approximately \$16,316.25

GST inclusive to be met from Parish funds.

3 October 2011 Waikohu Co-operating Church – The placement of a gift of a cross (work of art)

from Tina Baty, (artist) be installed in St John's Church, Te Karaka. This cross to be to the left of the sanctuary and it will alternate with a plain cross which is normally there depending on the liturgical season. It will otherwise be on the wall in the porch. No cost is involved.

10 February 2012

**Waikohu Co-operating Church** – The placement above the doorway to the nave of a Maori caring of Ihu Karaiti (Jesus) be installed in St John's Church, Te karaka. The carving and explanation of the symbolism and the 3 names of the Gisborne Boys' High School artists be displayed. A small koha of \$300 offered in appreciation.

13 February 2012

Parish of Gisborne/Te Hapara – The erection of an extension of facilities to the Te Hapara Whanau Aroha Early Childhood Centre which will result in the Centre increasing its child capacity by 17 places (50 in total) along with an upgrade occurring to the present facilities. The cost of the work is \$370,000 to be funded from Ministry of Education grant, parish contribution and community grants.

2 April 2012

**St James' Church, Mahora, Hastings** – The removal of the concrete slab(s)under the altar in the St James' Church, Mahora, for the health and safety of all people and provide a more workable worship space, together with the replacement of the worn carpet. The cost of the work is estimated at \$12,000 which will be paid from parish funds.

3 July 2012

**St Luke's Parish Rotorua** – The placement on the market for sale the property at 17A Bloomfield Street, Rotorua. The Government Valuation is: Land \$102,000' Improvements \$133,000; Capital Value \$235,000. Date of valuation 1 July, 2011. The property is to be marketed by 'The Professionals'. The cost of the sale to be the standard commission and legal costs relating to the sale of a residential property which will be paid out of the proceeds of the sale. Vestry approved the sale at its 17 April, 2012 meeting.
